- ✓ **The tax bill is sent to the owner of record regardless if the taxes are paid through a lending/mortgage/escrow company or by the taxpayer as the Missoula County Treasurer’s Office does not maintain this information. It is the responsibility of the property owner to forward a copy of the tax bill to the lending/mortgage/escrow company if needed.**
- ✓ Examine this bill carefully before paying. Be sure all legal descriptions are correct. The Treasurer is not responsible for payment on the incorrect property. Payments made in error CANNOT BE REFUNDED.
- ✓ Payment stub(s) must be sent with your check in order to receive proper credit for payments. Please refer to your TAXPAYER ID # on all checks and correspondence.
- ✓ We do not mail receipts for payments unless you provide a stamped self addressed envelope.
- ✓ Please make checks payable to: MISSOULA COUNTY TREASURER. Taxes paid by check are subject to the clearance of the check. We will honor post mark date as date of payment.
- ✓ For a change of mailing address, questions regarding the assessed market value of property or the legal description of property, contact the Montana Department of Revenue - Missoula office (406) 329-1400.
- ✓ If any of the following due dates fall on a weekend or holiday, the payment will be due on the next business day.

**REAL ESTATE TAXES** Real Estate Taxes may be paid in full on the FIRST due date, or in two installments. Each installment is due by the date shown on the front of this bill.

**MOBILE HOME TAXES** Mobile Home Taxes may be paid in full on the FIRST due date, or in two installments. Each installment is due by the date shown on the front of this bill.

**PERSONAL PROPERTY TAXES** Personal Property Taxes are due in ONE installment by the date shown on the front of this bill.

**DELINQUENT TAXES** When any tax payment becomes delinquent a 2% penalty is immediately added (per MCA 15-16-102). Also added is interest at the rate of 5/6 of 1% per month until paid (interest calculated daily). Please call Missoula County Treasurer at (406) 258-4847 for a payoff of penalty and interest figures on any delinquent taxes. In accordance with Montana Code 15-16-102 (5) the current year taxes must be paid in full before payment can be applied to prior year delinquencies. ONLY FULL YEAR DELINQUENCY PAYMENT, including penalty and interest can be accepted. The payment will be applied to the oldest delinquent taxes. WARNING! Delinquent taxes will be subject to tax lien purchases. As prescribed by law these assignments are available to the public.

**\*\*NOTICE TO PROPERTY OWNERS\*\*** Property valuation staff may be visiting your property to conduct a non-site review for property tax purposes. You or your agent may want to be present. If you wish to make an appointment, contact the local Department of Revenue - Missoula office at (406) 329-1400.
